WHEREAS, Ms./Mr. _____ admitted to MU for the degree of 4-year BS in Medical Technology – Clinical Laboratory Science, BS in Development Studies, BS in Economics, BS in Education program agrees to accept the terms and conditions governing this Financial Support Program.

Deed witnesses as under:

- a. This Financial Support in terms of Qarz-e-Hasna, given to the student, shall be for entire four year BS Degree program Starting from January 2019 (Spring 2019 Semester) till 2022 (Fall 2022 semester).
- b. The student shall abide by the decision of the university management who has provided this facility to its enrolled students.
- c. The Qarz-e-Hasna given to the student shall be strictly subject to the decision of the university management and cannot be challenged in any case.
- d. The student shall refrain from engaging himself/herself in any political, commercial or any other activity incompatible with his/her program of studies.
- e. MU reserves the right to invoke strict disciplinary proceedings against the student, in case he/she violates any provision of this bond.
- f. The student is liable to disqualification from the Qarz-e-Hasna Scheme in case he/she is found to have made any misstatement in his/her application.
- g. The student has agreed to repay the Qarz-e-Hasna amount which is Rs. 400000/- (Rupees four hundred thousand only) after completing the 4-year BS Degree requirements within five (5) years period in easy monthly installments. However, if the student wish to repay his/her Qarz-e-Hasna amount in lump sum during studies or soon after completion he/she can do so but after completing its first semester studies.
- h. The university will issue the transcripts/provisional certificate to the students after completing the 4-year BS Degree courses and other requirements to seek jobs or other relevant purposes.
